Description

The Alberta Canola Producers Commission, Saskatchewan Canola Development Commission, and the Manitoba Canola Growers encourage cutting edge, innovative research to enable the discovery and creation of value for the canola industry.

The Canola Agronomic Research Program (CARP), established in 1985, is a collaborative research funding initiative among the three provincial canola grower group commissions. The primary goal of this research program is to help canola farmers increase yield and profitability, reduce production risks, and enhance sustainability with effective technology transfer. To achieve these goals, they are soliciting 2022 CARP letters of intent (LOIs) on behalf of the three provincial canola grower associations and the WGRF. The Western Grains Research Foundation (WGRF) has once again expressed interest in participating with the canola grower organizations in potential funding for projects aligned with their research priorities.

Research priorities in the disciplines of agronomy, breeding, physiology, and integrated pest management, to name a few, have been identified through consultation with canola industry steering committees, the canola value chain, government and academic partners, and insights from the annual Canola Discovery Forum.
