### **Description**

The Centre for Aging and Brain Health Innovation (CABHI) is inviting point of care staff to “try something different” to improve the lives of older adults, persons with dementia and their care partners.

The mission of the Centre for Aging + Brain Health Innovation is to accelerate the development, validation, commercialization, dissemination and adoption of innovative products, services and best practices to support brain health and aging. CABHI's vision is a world in which people can age in the setting of their choice, maintaining their well-being and independence for as long as possible.

The Spark program is intended to support innovative products and practices informed by the experience of point-of-care staff working with older adults. CABHI invites staff working at Canadian not-for-profit healthcare organizations and Seniors Quality Leap Initiative (SQLI) members to apply for funding to develop or refine their grass-roots, early-stage solutions. Projects involving point-of-care staff testing or evaluating third party innovative solutions in a real-world environment will also be considered for funding under this program.

The lead applicant must be a point-of-care staff member working at an eligible Host organization (a not-for-profit healthcare organization in Canada, or; a member of the Seniors Quality Leap

Initiative (SQLI), either in Canada or the United States).

**U of G researcher will most likely be involved as a consultant or third party service provider. Please have the lead applicant discuss with CABHI for clarification.**

## **Eligibility**

CABHI will review all submitted applications to determine if projects meet the following criteria:

### **Applicant:**

- The lead applicant must be a point-of-care staff member working at an eligible Host organization. 'Point-of-care' staff perform work that directly affects older adults, and include:
  - Healthcare Professionals
  - Allied Health Professionals
  - Personal Support Workers
  - Certified Nursing Assistants
  - Support personnel
  - Support staff (for example dietary aides, housekeepers)
  - Home Healthcare aides
  - Direct clinical care and/or service staff
  - Point of care manager
  - Point of care researcher
  - Must be working at a healthcare delivery organization located in Canada or a member of the SQLI network
- The Host Organization employing the lead applicant, which will receive and administer project funding, must be:
  - A not-for-profit healthcare organization in Canada, or;
  - A member of the Seniors Quality Leap Initiative (SQLI), either in Canada or the United States
- If the Host Organization doesn't own the intellectual property (IP) in the solution being tested or evaluated, then the owner of the IP will be required to provide CABHI with a letter confirming, among other things, that it owns the IP, that Host Organization has the right to use the IP for the project, and that it understands that CABHI will have the right to publicly disseminate the findings of the project. The form of letter will be provided by CABHI.

### **The Solution:**

- Must clearly address at least one of CABHI's five innovation themes
- Must be sufficiently "innovative" in that it purposely differs from existing solutions

## **The Project:**

- Cannot involve basic research, primarily academic goals, subsidizing existing programs or initiatives at the host organization, capital investment in a portfolio of intellectual property, pharmaceutical trials or incubators for startups
- Focuses on the development and testing of an innovative solution at a healthcare delivery organization located in Canada/SQLI

## **Funding Availability**

Last year, CABHI funded 31 projects in the Spark program. In total, up to \$2.5 million is available across all projects.

## **Maximum Project Value**

The maximum funding available for projects selected in this call for innovations is \$50,000 (CAD).

## **Project Duration**

The Spark program will be funding projects that are scheduled to run for 12 months, starting in October 2019.
