Marie Skłodowska-Curie Actions – Individual Fellowships – Global Fellowships

### Description

The Marie Skłodowska-Curie Actions (MSCA) aim to support the career development and training of researchers – with a focus on innovation skills – in all scientific disciplines through international and intersectoral mobility. The MSCA are expected to finance around 65,000 researchers between 2014 and 2020, including 25,000 doctoral candidates. The MSCA will address several objectives of the Europe 2020 strategy, including the Innovation Union flagship initiative. By funding excellent research and providing attractive working conditions, the MSCA offer high quality professional opportunities open to researchers of any age, nationality or discipline.

### Eligibility

The University of Guelph can participate in this call as a Partner Organisation, which means it can host outgoing researchers from the EU for an uninterrupted period of between 12 and 24 months, followed by a mandatory 12-month return period to an institution located in the EU or associated country. University of Guelph faculty are eligible to supervise outgoing researchers from the EU under this call.

### Funding Availability

No funding will be transferred to the University of Guelph; funding will be provided to the outgoing researchers' host institution.

### Project Duration

A period of between 12 and 24 months.

As a partner organisation the University of Guelph must agree to host the researcher during the initial outgoing period and provide training. Partner organisations involved in a Global Fellowship must include (in Part B of the proposal) an up-to-date **letter of commitment** to ensure their real and active participation in the proposed action; their precise role should also be clearly described in the proposal. For Global Fellowships, if the letter of commitment of the TC partner organisation is not provided, the proposal will be considered incomplete and therefore will be declared inadmissible.

Letters of commitment from the University of Guelph are to be scanned and inserted into the application prepared by the researcher/host institution (Section 7 of the PDF file in part B).

The suggested minimum requirements for the letter of commitment are:

- heading or stamp from the institution;
- up-to-date (i.e. issued after the call publication date, 12 April 2016);
- the text must demonstrate the will to actively participate in the proposed action and the precise role;
- signed by the legal representative.

Letters of commitment signed by the University of Guelph will be co-signed by the ADR of the host college, and the Associate Vice-President Research Services.

## Internal Deadline

[Please submit 1\) a copy of the host institution's application, 2\) a draft of the letter of commitment, and 3\) an OR-5 Form to \[research.services@uoguelph.ca\]\(mailto:research.services@uoguelph.ca\)](#) [1] two (2) weeks prior to the intended final submission deadline.

## External Deadline

Applications submitted by the researcher's host institution in the EU will be accepted until September 14, 2016, 17:00 Brussels local time.
