## **RESEARCH PROPOSAL**

Research proposals should not exceed ten (10) pages . This limit does not include references, tables, graphics, figures and photographs. Use at least 12 point font and standard margin all around.

- 1) Relevant documentation for the project
- 2) Objectives and assumptions
- 3) The research plan
  - a) specific objectives
  - b) methodology
  - c) sampling method and rationale for sample size
  - d) data analyzes
- 4) The relevance for hereditary ataxias
- 5) A list of references presented in an accepted format

### **RESEARCH GRANT APPLICATIONS CHECKLIST**

Applicants are asked to use the checklist below to ensure all conditions are met and the application is properly prepared

- 1     Signature of department head and chair or signing officer of the sponsoring organization.
- 2     Professional information sheet or CV for the candidate and each co- candidate.
- 3     Publications.
- 4     List of all grants, scholarships currently held, approved or requested and link between this proposal and all other funded projects
  
- 5     Ethical and Safety Considerations.
- 6     Budget.
- 7     Scientific summary, simplified summary
- 8     The research proposal, not to exceed ten (10) single-spaced pages, excluding references.

### **NOTES:**

- Ataxia Canada - Fondation Claude St-Jean will acknowledge receipt of the request. The candidate must ensure that the application is complete. Incomplete applications will not be considered.
- The scientific evaluation committee will select external evaluator for applications which require qualifications that the committee members do not have. If desired, the candidate may submit, in the cover letter, the names of three experts who do not come in conflict of interest with the proposed research project.
- The candidate undertakes to submit to Ataxia Canada - Fondation Claude St-Jean a written report of the research work funded by the grants granted and to present at the annual general meeting of the Association an oral presentation of his research work
